This, despite the major disruption of added work and stress involved in clearing out our old space and moving into a new one.

Throughout the year, the staff and volunteers kept their focus on our mutual goal of making West Broadway a more just and livable neighbourhood.

Report from Executive Director, Greg MacPherson

This has been a memorable year for West Broadway Community Organization (WBCO), and I am very proud of my colleagues and our many community partners for twelve months of accomplishments and good memories. From partnering with Local Investment Towards Employment and Neighbourhoods Alive to create over twenty part time jobs for local residents, to facilitating the launch of the West Broadway Bear Clan patrol, WBCO continues to ensure resources are brought to our neighbourhood and put to the best possible use.

We worked closely with our partners at Agape Table to help ensure a healthy transition for this irreplaceable institution from its long time home at All Saints Church to its future home on Furby St. In a year of tightened budgets, WBCO maintained all core programming at the highest level possible, and saw significant increases in the number of local residents volunteering and participating in our activities. The Good Food Club now has over 1200 annual members, our Property Improvement Program (PIP) leveraged over \$40,000 in private investment towards exterior fix-ups, eleven local youth found first time employment (as well as training, identification and bank accounts!) with the West Broadway Snow Team, and both our annual Soball Winter Carnival and Spring Clean-up events were enormously successful.

2017 ended with the sale of our longtime home, the bright green house at 608 Broadway, and a move down the street into the beautiful and historic 'Klinic Building', at 545 Broadway. This move not only ensured that this heritage property would remain a community asset for years to come but facilitated the introduction of two small businesses to storefronts previously occupied by non-profits.

As always, the simple recipe for building a brighter future continues to be good people investing genuinely in one another and in their community. Over the following pages my colleagues provide highlights of their many accomplishments over the past year, please know that this represents only a fraction of their impact on West Broadway.

West Broadway's Community Safety Program

In keeping with the priorities of West Broadway's Community Plan (2016-21), WBCO's Community Safety program provides resources, relationship building opportunities, and empowering information to community members who are genuinely vulnerable and/or isolated. Activities are organized along three fronts: Community Wellbeing (crime prevention), Active Transportation (pedestrian and cycling safety), and Capacity Building (network and relationship building).

2017-18 Program Highlights:

• Snow Team: Eleven youth were hired to clear ice and snow from West Broadway's walkways, bus stops, and medical clinics. This effort also included a fee-for-service providing snow clearance to


businesses and residents on a sliding scale

- Partnered with Bear Clan Patrol inc to expand Bear Clan's neighbourhood safety patrols into West Broadway. Indigenous-led volunteer-based patrols now operate every Friday and Saturday evening!
- Hosted a community feast to welcome the Bear Clan Patrol into West Broadway over 200 attendees
- Co-hosted the Annual March for Peace in partnership with DMSMCA and SNA over 200 attendees
- WBCO instigated a partnership with the University of Manitoba Department of City
 Planning and worked with a class of Masters students on a three month research project highlighting the potential for active transportation infrastructure in West Broadway



2017-18 Snow Team

- Hosted a Harm Reduction workshop with Street Connections on the context of drug-use in Winnipeg, and strategies for improving safety in West Broadway – 14 Attendees
- Conducted several safety audits with businesses and community members, strategizing ways to address concerns
- Organized and hosted six Inner City Safety Group meetings and four steering committee meetings to address the recent spike in criminal activity, intravenous drug use, and rough sleeping in our community.

West Broadway Community Gardens

West Broadway Community Organization owns and/or manages eight community gardens and several raised bed gardens at neighbouring residences. Management efforts include:

- Allocating plots, providing resources as well as organizing and communicating with gardeners
- Organizing community volunteers, supervising the compost coordinator, two Urban Green Team garden staff, and two
 Green Wave summer staff from Take Pride Winnipeg, as well as community members performing odd jobs
- · Organizing educational garden related workshops, work parties, and community events
- Supporting greening efforts and initiatives in West Broadway
- Partnering with neighboring community organizations on programming
- Trying to increase the number of green sites in the community, and access to those that exist

Accomplishments in 2017:

Kid's Garden Program: Over 55 children visited the kids garden in 2017 to learn about gardening, nature and the environment

545 Permaculture Project: Now in its fifth season, this garden offers residents hands-on learning in traditional garden practices, plant knowledge and provides the community with access to traditional medicines and food. All members of the community are welcome to come and pick food for themselves and their families from this garden. Our thanks to Audrey Logan and her community team for their hard work in making over 70 types of edible plants available to our community!



Edible Trees and Shrubs of West Broadway: Many of our 21

edible fruit trees and shrubs have been maturing beautifully. To put this into perspective, one single fruit tree such as the Dwarf Apple Tree planted in the Tot Lot can produce four bushels per year once matured for a few years — this is 180lbs of apples from just a single tree in a single year! The 10 dwarf apple trees planted last year could produce as much as 1800lbs of apples on a good year with almost no further input required! We also maintain Crabapple, Large Apple, Cherry, Hascap, Apricot Saskatoon, Gooseberry, Raspberry, Strawberry, and Wild Plum trees, all steadily growing into their full potential

Workshops/Events: We provided a comprehensive selection of 10 garden related events to West Broadway residents throughout the 2017 garden season with an average attendance of 11 people. These events included workshops on vermicomposting, rain barrel making, beneficial pollinators, container gardening, soil health, plant sale and give-away, plant identification walk, first time gardening, composting, and mushroom growing

Pollinators: Each of our community gardens features a number of indigenous prairie plants. This important genetic stock provides critical habitat while bringing medicine, food, and capacity into our community

We currently have over 143 gardeners and volunteers working at eight sites in the community. Also, these folks make our work possible: Art City, Mulvey School, West Broadway Youth Outreach, Resource Assistance for Youth, Broadway Neighbourhood Centre, Wolseley Family Place, Great West Life, Fort Whyte Farms, Sage Garden Greenhouse, Red Valley Plant Market, Scott's Canada, Andrew Hogue, West Broadway Biz, Klinic Community Health Centre, Green Action Centre, University of Winnipeg (EcoPIA), Manitoba Eco Network, Prairie Flora, Winnipeg School Division Newcomer Program, Winnipeg Harvest, Westminster Housing Society and the Winnipeg Regional Health Authority.

The Good Food Club

The Good Food Club (GFC) is a community-led program, an actual 'club' that is open to people of all backgrounds, mobilizing inner city residents to improve food access while addressing complex social conditions of poverty, unemployment, isolation, and chronic physical and mental illness. GFC had a very successful year in 2017-18, thanks in no small part to the support and hard work of our numerous volunteer club members.

Here are some of the highlights:

- 4,050 community members attended community events where food was provided by Good Food Club
- Three large scale community dinners provided nourishing food, volunteer experience, and good company to
 1200 people
- 112 GFC members took trips to the farm
- 400+ local youth who took part in GFC Kids Cooking
- 50 members took part in cooking classes
- 140 members took part in skill building workshops
- 35 members attended Safe Food Handling courses

Good Food Boxes & Markets: GFC assembled and distributed 800 Good Food Boxes at 16 indoor GFC Mini-Markets this year. Over \$12 000.00 worth of healthy food! GFC also held 12 West Broadway Farmers' Markets, providing over \$7000.00 in sales



GFC staff: Ailene, Michael, and Kelly (front), volunteer club members and 150 Good Food Boxes assembled for the Fresh Food Christmas Hamper pilot project. 300 families received hampers this holiday season!

Healthy Cooking Workshops: GFC held ten healthy cooking classes and food related workshops for adults with 125 participants in attendance. Fourteen Kids Cooking sessions were offered this year, each with an average of 30 participants per session.

Employment Essentials: Eleven employment training and skill building workshops were offered this year by the Good Food Club, with 160 participants in attendance.

Farm trips: The Good Food Club facilitated 16 farm trips in 2017 with an average of seven participants per trip

Summertime Family Party: Our second annual Good Food Club Summer Fun Fest this year was a huge success! Over 280 children and their families attended this day of fun, fitness and learning.

GFC Seniors Committee (NEW): The GFC introduced a very popular monthly 'Healthy Seniors' Committee this year







Housing Initiatives Coordination

The West Broadway Housing Department was headed by Housing Coordinators Kelly Frazer in 2017-18 and Stefan Hodges as of April 2018. The Housing Coordinator supports the implementation of West Broadway's Five-Year Housing Plan (2014-2019) in association with local residents and stakeholders

2017-18 Housing Highlights:

WBCO's Property Improvement Program (PIP)

In 2017, PIP disbursed \$21,496.95 in exterior fix-up grants, awarding 8 to rental landlords and an additional 7 to homeowners. In 2017 alone, PIP leveraged \$41,984.42 in private investment.

Advocacy, Education, and Resource Support for Renters and Landlords

- WBCO works to ensure that the perspectives and priorities of local property owners and tenants are
 upheld through membership in the West Broadway Housing Stakeholders Committee, End Homelessness Winnipeg, the Right to Housing Coalition, Winnipeg Rental Network, the Rooming House Organizing Committee, the Rooming House Task Force, and the Bed Bug Management Committee
- In 2017, WBCO helped re-launch a West Broadway Tenants' Committee. The Tenants Committee has
 begun to build an organizing structure for tenants to share concerns and work collectively to solve issues that affect the community at large.
- The West Broadway housing front-line workers network was launched, holding quarterly meetings for West Broadway-based housing support workers to discuss strategies and share resources.

INDEPENDENT AUDITORS' REPORT

To the Members of West Broadway Development Corporation

We have audited the accompanying financial statements of West Broadway Development Corporation, which comprise the statement of financial position as at December 31, 2017, and the statements of operations, changes in net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian Accounting Standards for Not-for-Profit Organizations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit, We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditors consider internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for Qualified Opinion

In common with many not-for-profit organizations, the Organization derives revenue from grants and donations, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of the Organization. Therefore, we were not able to determine whether any adjustments might be necessary to contributions, excess of revenues over expenses, and cash flows from operations for the year ended December 31, 2017, current assets and net assets as at December 31, 2017.
